Which Cookies Are Used For Which Purposes?

As Rizom Beach Hotel, we use cookies for various purposes on our site and application and we process your personal data through these cookies. These purposes are mainly:

- **To analyze the Site and the application, to increase the performance of the Site and the application.**

For example, the integration of different servers on which the Site operates, determining the number of visitors and adjusting performance accordingly or making it easier for visitors to find what they are looking for.

- **Cookies Used on Our Site**

Mandatory Cookies: These are technical cookies that enable the website to function correctly and allow you to use its features. They are in the session cookie category. If these cookies are blocked, it will result in the inability to use the website features. The consent of our visitors is not required for the use of mandatory cookies.

Analytical Cookies: Rizom Beach Hotel uses analytical cookies to improve your website experience. Analytical cookies allow us to understand how our visitors use the website (eg which pages they visit, duration of visit, etc.). In this way, we can improve the content we offer or change the website design. Google Analytics, one of the web analysis tools, is used for analytical purposes. What Are Your Rights as a Data Owner?

Data owners pursuant to Article 11 of the KVK Law,

- personal data is processed,
- requesting information on personal data if it has been processed,
- personal data and whether they are used in accordance with its purpose,
- the country or abroad,

- Requesting correction of personal data in case of incomplete or incorrect processing and requesting notification of the transaction made within this scope to the third parties to whom the personal data has been transferred,
- Requesting the deletion or destruction of personal data in the event that the reasons requiring its processing have disappeared, although it has been processed in accordance with the provisions of the KVK Law and other relevant laws, and requesting that the transaction carried out within this scope be notified to the third parties to whom the personal data has been transferred ,
- Objecting to the emergence of a result against the person himself by analyzing the processed data exclusively through automated systems,
- has the right to demand the compensation of the damage in case of loss due to the unlawful processing of personal data.

Depending on the nature of your request, your applications will be concluded free of charge as soon as possible and within thirty days at the latest; however, for written responses over ten pages, a fee may be charged based on the fee schedule stipulated by the Personal Data Protection Board.
